3 MINUTES OF PREVIOUS MEETING

4 BUSINESS ARISING FROM THE MINUTES

4.1 "Friendship in Song." Choir Promotion on You Tube.

No progress has been made without live rehearsals possible.

4.2 Social Media

Report. MP advised that we are still attracting visitors. Inquiry concerning someone who it was believed may have sung with the Choir at the Harbour Bridge opening in 1932 was unable to be fully met – record keeping at this time was almost non-existent in the Choir so a definitive answer was not possible. The inquirer has been advised accordingly.

4.3 MCAA 2020

Several members responded to our request for suggestions to re-set 2020 goals by indicating their support for the concept of a trivia night. No further suggestions were received. Discussion of the possibility of directing some of the funds raised from such a night to a charity or local cause — will be discussed when proceeding. J. Mealings and D. Woodside have a framework prepared and further planning will be advanced when COVID-19 restrictions permit.

4.5 Bogle DVD (BP, RR)

JM has contacted Uel B and Morrie D (who has had his jacket dry cleaned) and has been in regular contact with Tom F.

BP advised that Alwyn is doing well with farm visits and ongoing work to assist his use of an iPad. He and Gillian are looking to ultimately move to town.

4.7 Ongoing Memberships

No notice of potential new members for ZOOM rehearsals. DK, DH and MP have possible new recruits awaiting resumption of in-person rehearsals.

4.8 Associate Life Membership

Adrienne Seymour's life membership has been confirmed in a written letter to her. DW has unearthed a 1991 letter to Donna Riles which offered her honorary associate membership. Both names have been added to our master Members Register

DW spoke of the need for defining more clearly our relationship with our Life Members, especially those who have become inactive. At present we have very little interaction and we need to identify opportunities to engage with them. The most likely of these would be dinners, social occasions, concerts, occasional rehearsals etc. It was suggested that we might invite them as non-paying guests to our Annual Dinner. It was further suggested that our initial email contact with members, when we become active again, might include them and invite their comments/suggestions. MP suggested that a member/s be appointed to take responsibility for communication and contact with them.

MP raised the possibility of seeking reduced insurance premiums for 2020 given our inactivity.

7 MUSIC DIRECTOR'S REPORT

7.1 Report on ZOOM rehearsals

BP reported that his ZOOM rehearsals have gone well. DK and DH confirmed that they have been worthwhile and should continue while possible. MC felt Bass rehearsals have been largely positive but noted that the last ones had been limited to 40 minutes by ZOOM.

BP will soon focus on different rehearsal repertoire with the postponement of the MCAA concert to 2021 – mostly those items on which work commenced at the beginning of the year and repertoire for a possibly re-scheduled concert with Cantar for late this year. BP would like to re-schedule the Forbes concert if possible and undertake some performances in nursing homes. Another vocal goal for the year will be to complete recording of the CD and a new recording of "Friendship in Song" for the promotional video. BP has had encouraging discussions with a possible MD and will continue to provide musical direction until a new MD is in place (hopefully later this year). Plans for a testimonial dinner for BP (and retiring Life Members) will be made when normal activity resumes.

The meeting discussed a possible timeframe for resumption of in-person rehearsals. All members feel ongoing caution is required given our demographic and the nature of our activity but the general hope is that a staged return to in-person rehearsals will become possible by September/October. It was noted that the logistical issues will require good management with the appointment of personnel to maintain safe practices. OMVC's policy on COVID-19 will be updated in accordance with official advice as it permits change to our current practice. ORC's policy will further determine when/how we are to operate at ORC.

Action: DW to make contact with D. Riles at ORC to gauge ORC's thinking on the resumption of their full activities and the possibility of limited OMVC rehearsals (4 singers with conductor) in the near future.

7.2 Succession Plans

BP advised the meeting of the latest developments in this area and a meeting with himself, DK, DW and a potential conductor will be scheduled for Friday, 19/6. The meeting will report to the Management Committee and subsequently to the full choir membership.
